## LiBERTADO - The definition

*Rather poor and healthy than rich and sick* is an old German proverb that offers two unacceptable options to choose from. It is better to follow the maxim "Everyone is the blacksmith of his own fortune". Those who have this as their motto will rather strive for personal freedom, financial independence, and continuous further development.

Society, politics, and bureaucracy, however, ensure that this is not easy to do everywhere. For this reason, there have always been efforts to free oneself from state constraints and to organize oneself. Current examples are Gebel with its concept of *Free Private Cities* in Honduras and *Seasteading* in French Polynesia.

These projects required years of negotiations and extensive agreements with the respective governments. Instead, LiBERTADO relies on existing law, does not need special regulations, and is, therefore, easier and quicker to implement.

In Ayn Rand's novel "Atlas Shrugged", society's top performers elude an escalating bureaucracy and its parasites. One after the other disappears, all together find themselves in a scenically attractive and outwardly completely shielded place - *Galt's Gulch*.

It is alarming how this fiction from 1957 reveals parallels to the present day.

## LIBERTADO - Priorities

To be free means first and foremost to be financially independent, i.e. to have sufficient resources or to earn them when needed in order to be able to live a chosen lifestyle. Entrepreneurs run or sell their businesses, inventors live on patents, artists sell their works and many young people finance a comfortable life with various online activities. LIBERTADO wants to offer all of them an optimal environment in every respect.

To be free also means to be largely free from the constraints of politics & bureaucracy. Those who have to finance unloved politics and incompetent politicians with half their income are not free. Those who have to spend a relevant part of their lifetime fulfilling bureaucratic requirements are not free. Those who are unable to leave their home country due to earning a living or legal constraints are not free.

It is not just about moving to another place and saving money. It is about personal transformation and life energy.

Step 1: Change your personal life.

Free yourself from politics, bureaucracy, professional and private stress, instead settle down in a LIBERTADO community of your choice, relaxed and open for further development.

Step 2: Transform your personal and social status.

Concentrate the gained vitality on creativity, on the health of mind and body, surround yourself with inspiring people.

Step 3: Transform your purpose

Turn your experience into methods to master the future and help others keep pace with exponential technological progress.

What could these transformations mean to you?

The simple answer is to start a whole new life.

Free from circumstances, pressures, and negativities of the past opening up new horizons, gaining new insights.

A word on taxes:

Whenever someone declares that they want to live freely and independently, there is often the assumption that it is about tax avoidance. This is wrong for many reasons.

First, LiBERTADO residents have mostly contributed above average to the community and continue to do so, according to their ideas. They do not owe any state anything.

Secondly, the principle that the person who orders the music also determines what is played has been largely overruled in many states. Independent of elections and at the expense of taxpayers, supranational bureaucracies (EU/UN) and NGO's are gaining more and more influence without any democratic legitimation.

Third, everyone is free to decide where in the world they want to settle, in accordance with the rules of the target country, of course.

Tax laws are one of the legitimate criteria to consider when planning a move. After the payment of domestic liabilities and the intention to abide by the rules abroad, there is no reason to justify oneself. If the rules are more favorable abroad, then so be it.

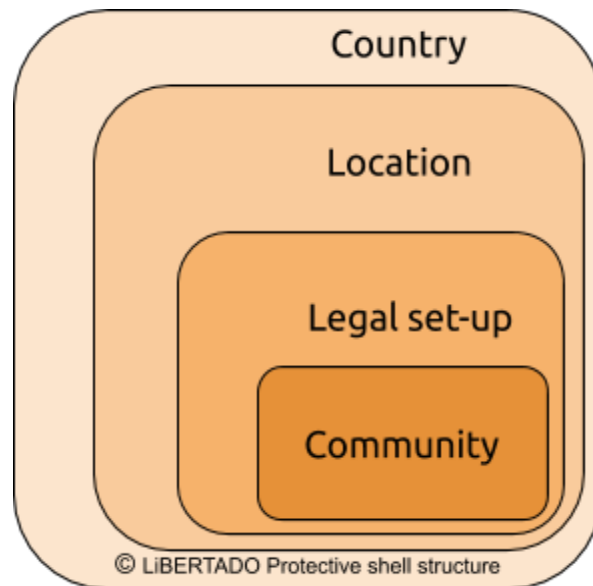
A rational tax system is, for good reasons, one of the decisive factors for competitiveness between countries. It is also a contract between the state and its citizens. As soon as they feel an imbalance between taxes paid and benefits paid, they have every right to consider a change - by election or by resignation.

Wherever more and more service providers leave the country, politicians from outside the world seek to enforce uniform tax rules worldwide, so that no one can escape.

That would be the way to dictatorship, not more freedom.

## LIBERTADO - The structure

LIBERTADO is based on this structure consisting of 4 components:



The most important component is to choose a **gRUY** for permanent residence that taxes according to the territorial principle, i.e. only income generated domestically, whereas foreign income is tax-free and usually does not even have to be declared.

Those who have cut all tax connections cleanly in their country of origin and generate income from outside the target country no longer have to be accountable to any financial bureaucracy. This is the ideal situation.

Of course, other criteria play a role in the selection of the target country:

Economic and political stability, security, infrastructure, climate, etc.

High demands are placed on the location of a LIBERTADO **WUjcb**:

To offer a natural and restful environment, to offer attractive leisure possibilities, away from industry and tourist masses, but also in the wider catchment area of a metropolis with cultural offers. There must be comfortable apartments and houses to choose from, including complete infrastructure.

As a LIBERTADO resident, you need a **U'gYh d** to manage and protect your assets. This can be a corporation or a foundation.

Whether you use them to conduct business outside your country of residence or in third countries depends on the individual case.

The country of residence must have a proven legal and stable banking system.

While LIBERTADO RESORT does not build up its own assets, this is more complex in LIBERTADO PARK and requires a specific legal framework.

Whoever settles in a LIBERTADO property automatically becomes a member of the local LIBERTADO **Wa a i b]m**

Its focus will be networking for the further development of the own enterprises and personality in the LIBERTADO RESORT.

In LIBERTADO PARK, the quarter of high-potentials, challenging projects for the future can be pursued in harmony with personal goals and potentials.

As the location for LiBERTADO RESORT 507, we have chosen Playa Blanca, a resort on the well-developed Panamericana 120 km from the capital.

A gated community with hotel and restaurants, a 3 ha saltwater lagoon and fully equipped condos with 132 m<sup>2</sup>, 2 bedrooms/2 bathrooms, and loggia. Airport, marina, mall and golf courses are within a few kilometers.

In short: Up to 6 owners own a Panama Corporation that owns such an apartment. Thus each shareholder has access to 8 weeks of stay per year. A concierge service takes care of everything (booking, cleaning, repairs, delivery/acceptance). Initial investment from \$50,000, running costs from \$1,200 annually.
